3.1 Policy change - Request: WHOIS Policy & Acceptable Use Policy

Recap:-

- Strong consensus for the changes
- Phasing of implementation is under discussion

WHOIS Changes

Proposal to include Billing Contact information in the WHOIS display

- It was proposed that to support secondary market operations, the Billing Contact nic-handle and name managing a dot IE registration should be included in the WHOIS display.
- This would direct interested buyers to the Registrar managing the domain to initiate sale discussions.
- There was strong consensus for the change, and it was suggested that this opportunity also be used to make other changes to the WHOIS display, including the removal of the legacy class and category system and the introduction of a Registrar Abuse Contact.

3.1 Policy change - Request: WHOIS Policy & Acceptable Use Policy

Action Points:-

- As requested, IEDR has delayed rollout until after 4 Nov (date of changes to API)
- IEDR to engage with the wider accredited .ie Registrar channel in relation to establishing an appropriate timetable for the implementation of the proposed changes to the WHOIS output; to display the Billing Contact name, along with other functional and aesthetic changes.

Update:-

- IEDR will work with the channel to establish a suitable time frame for the implementation of the proposed changes in Q1 2018. Updates will be provided in due course.

3.2 Policy change - Request: Privacy Policy

As requested, IEDR has delayed the rollout of the revisions, pending feedback from Registrar's legal advisors and IEDR clarifications

Action Points:-

- Registrars to engage with its legal advisors and tech staff, and revert with edits to the draft
- IEDR to provide clarification on data retention practices within the proposed policy edits, in due course.

Updates:-

- IEDR's existing data retention practices have been documented, and will be circulated to the PAC.
- Changes to IEDR's retention practices for GDPR compliance will be documented and circulated in due course.

Action Points:-

- Further updates will be provided in due course.

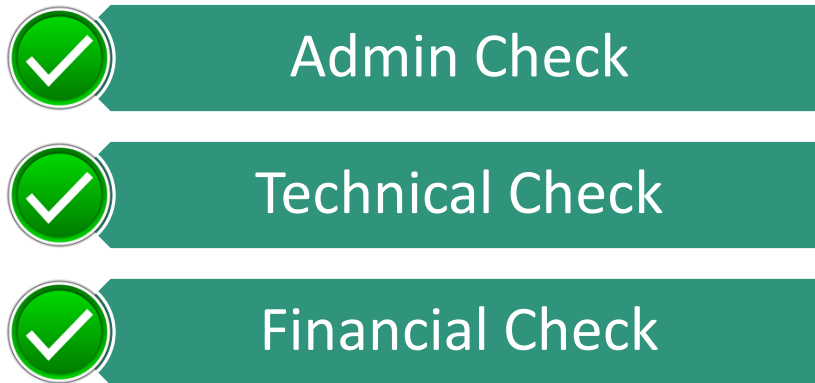
3.3 Proposal to alter the operation of the DNS check validation process

To ensure that a FAIL result on the technical check does not delay the completion of a request

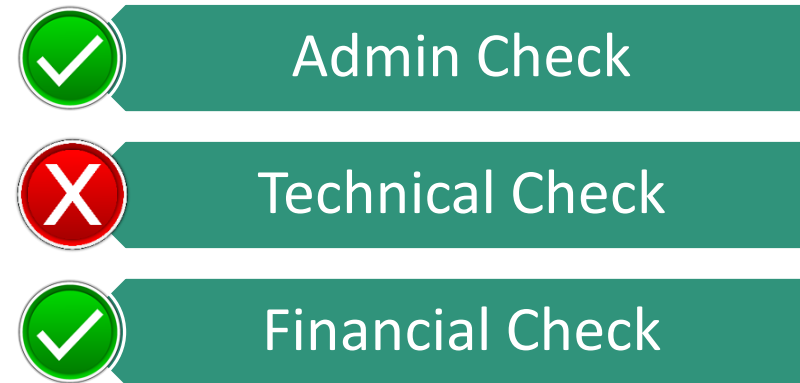
What is being proposed?

- The triple-pass check would continue to run.
- A **FAIL** result on the technical check would not delay the completion of the request, provided that the admin and financial checks are successful.

Checks that requests must pass currently:-



Checks that requests must pass after proposed change:-



- Email notifications will issue to the relevant contact(s) to notify them of the DNS configuration failure, but the correction of this would not delay the completion of the request.
- IEDR is in favour of this change to enhance the customer experience. We will monitor the impact of the change and if there is a deterioration in the quality of the zone, we may need to re-visit the DNS check process.

3.3 Proposal to alter the operation of the DNS check validation process

To ensure that a FAIL result on the technical check does not delay the completion of a request

Background on the current process:-

Ticket requests (e.g. new registration, modification, billing transfer and registrant transfer) are subject to a **triple-pass check** before they are completed (i.e. before the change takes effect in the dot ie zone).

The three stages that form the triple-pass check are outlined below:-

- The **admin check** determines that the applicable administrative requirements have been met (e.g. supporting information has been provided to show compliance with registration rules for new applications, or a valid authcode has been provided for billing contact / registrant transfers).
- The **technical check** determines that the DNS records provided in a request are configured in accordance with RFC protocols 1034 & 1035.
- The **financial check** determines that the required fee, if applicable, has been paid (via deposit account/credit card).

If a request **fails** any **one** of these checks, the request cannot complete, until the **three** checks successfully pass.

Policy change – to remove the claim to the name requirement from the Registration & Naming Policy

Action Points:-

- PAC Secretariat to analyse the categories of responses received, and compile a report detailing this analysis for circulation to the Working Group and wider PAC.

Public Consultation response summary:-

117 responses were received during the consultation process.....

Overall Proposal	73 participants were in favour of the change	62.4%
Positive Step	75 participants believed it was a positive change	64.1%
Faster and Easier	92 participants agreed that registering a .ie would be faster and easier	78.6%
Personal Name Variations & nicknames	93 participants were in favour of allowing the registration of these names	79.5%
Safety of the Namespace	80 participants agreed that the safety of .ie names would not be adversely impacted	68.4%
International Cyber-Squatters	79 participants agreed that the connection to Ireland requirement will deter these squatters	67.5%

Marketing & promotion - Communications & Awareness building

Phase 1 of communications has ended - Public Consultation (28 Aug '17 – 30 Sept '17)

Phase 2 of communications is ready to commence.....

- Registrars - awareness building for existing registrants and current customers (*final call* to ring-fence your name)
- IEDR - toolkit for Registrars and PAC Mothership Stakeholders is ready to go, and will include:-
 - Informational Flyers
 - Short animation videos (x2)
 - Skyscraper banners (for digital ads)
 - Sample content for social media, stakeholder websites, articles etc.
- IEDR website – will have FAQ, informational flyers, home page carousel, timetable etc
- All - awareness building by stakeholders (to ring-fence your online-identity, name)

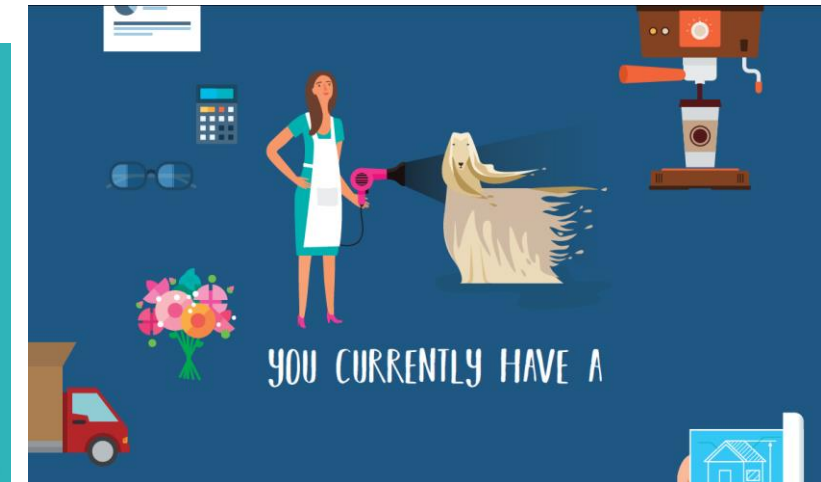

Connection to Ireland - Guidelines for showing evidence

- Before implementation, further consideration still required for a few Guidelines:-
 - **Organisations** (e.g. clubs, bands etc.)
How should these bodies show their connection? e.g. VAT number, RBN number, register to individual, use social media links?
 - **Utility bills**
Do these provide suitable evidence of a connection and proof of identity?
 - **Non-citizens / -residents of the island of Ireland**
Should these parties be eligible to hold a .ie in any particular cases?
- Further word-crafting and discussion required
- Draft edits to the PPPRG:-
 - Registration & Naming Policy 'Guidelines' within the PPPRG to be revised after further discussion with WG

5. Policy change – claim to the name

Fast-Pass Registration Process Proposal
For returning customers – post implementation

During the Working Group deliberations, consensus was found to exist for this FastPass proposal:-

- At go-live, IEDR will continue the legacy, 'off-line fast-pass' process
- NB – no system changes will be required to Console nor API
- Applications will be accepted (from returning customers), without 'Connection' documentation
- Existing registration name (of the returning customer) should be 'flagged' in the ticket remarks
- Applications / mods are (largely) processed on day of receipt, so this will result in a positive and fast registration process
- Post go-live, IEDR will monitor the need for an automated 'fast-pass' process (aka "straight-to-database")

6. Alternative Dispute Resolution (ADR) Policy

'Appeals-lite process' – objective is an easier and affordable process

Action Items:-

- As consensus-in-principle was found to exist for the proposal, a Working Group was to be formally established to further consider the proposal.
- IEDR to provide some information on past complaints / disputes / mediations to the WG
- PAC members to provide examples / case studies / experiences to the WG

Updates:-

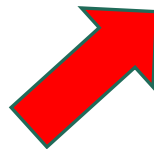
- Working Group has been established and will:-
 - Engage Law Society on the proposal
 - Consider if a third party should / could manage the process
 - Consider if a mediation service should be offered with the process
 - Consider alternatives /options for an ADR process (that are easier and more affordable than the IE DRP with [WIPO](#))
 - Consider practices of other ccTLDs/gTLDs (plus context of EU Digital Single Market regulations)

.ie namespace – dealing with Complaints, Appeals and Disputes (in effect on 1 January 2017)

The Working Group will review industry best practices for:-

- Dispute Resolution,
- Protection of Intellectual Property Rights,
- Co-operation with Law Enforcement,
- Customer service and complaint handling,
- Appeals processes,
- Facilitation by professional Mediation / Expert services.

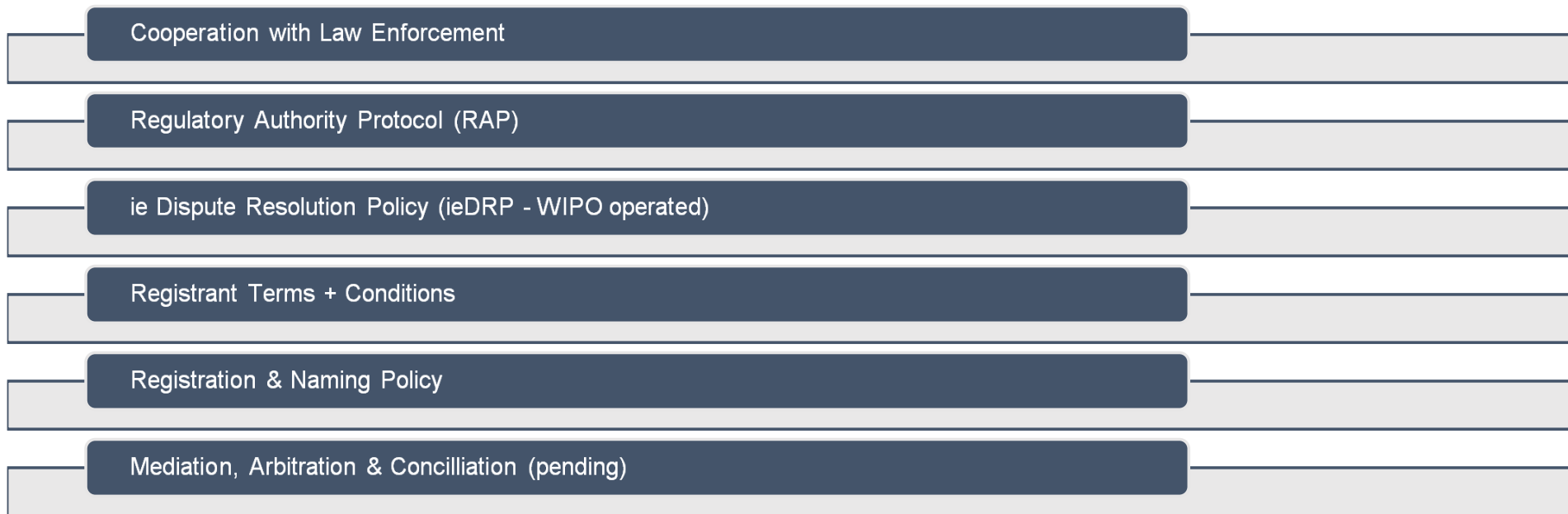

Complaint handling in the dot ie namespace

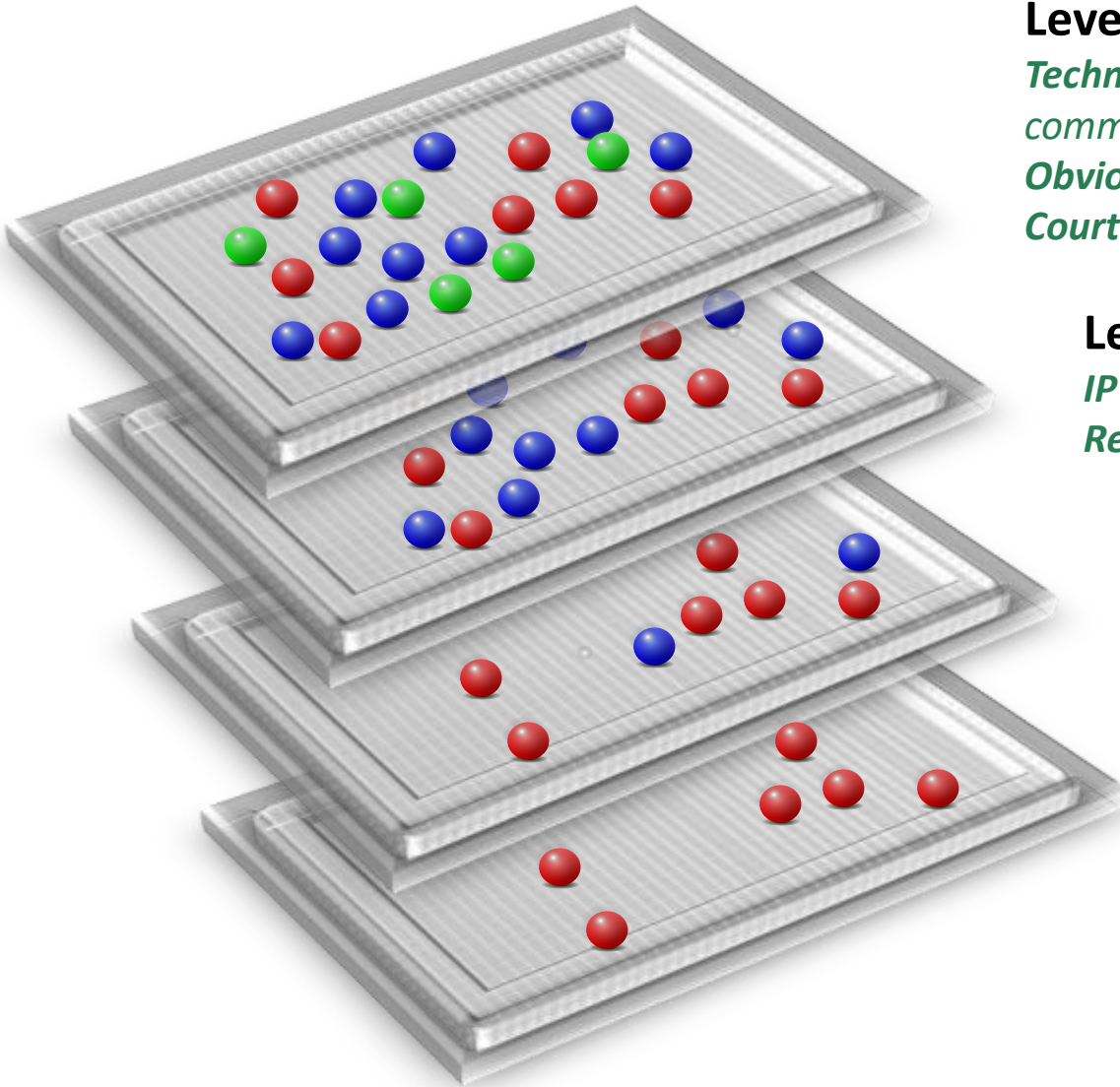
Package of mechanisms currently available for handling disputes and complaints

The graphic illustrates the package of measures that are currently available for the handling of complaints and disputes that arise in the dot ie namespace. The IE Domain Registry (IEDR) facilitates a number of mechanisms for handling complaints regarding **a domain name registration only**.

Complaints should be submitted via email to complaints@iedr.ie. All complaints are responded to within 1-2 working days

Level 1: IEDR can filter and deal with cases, such as :-

***Technical abuse** – malware, phishing, DNS hijacking or poisoning, botnet command and control, willful distribution of malware.....*

***Obvious illegality** - distribution of child pornography, human trafficking*

***Court Order** – including an instruction to suspend, delete a domain*

Level 2: WIPO and Regulatory Authority protocol (RAP)

***IP infringement:-** complainant sends to WIPO directly*

***Regulatory body** - notice of illegal activity - existing protocol (RAP)*

Level 3: Registration abuse

***Breach of t&c's during registration** - incorrect supporting documentation*

Level 4: complex cases – refer to Expert Panel, Courts

***Legal matters:-** defamation, slander, impersonation, passing-off*

***Registration issues:-** bad faith registrations, non-rights IPR breach*

***'Ownership' issues:-** Business disputes, family disagreements*

Complaint handling in the dot ie namespace

WIPO - administered by the WIPO Arbitration and Mediation Center (the Center)

1. **Three** hurdles to cross:-

To be successful in an ie DRP, a Complainant must prove to WIPO that:

- a domain name is identical or misleadingly similar to a ***protected identifier*** in which the Complainant has rights; **and**
- the Registrant has ***no rights in law*** or ***legitimate interests*** in respect of a domain name; **and**
- a domain name has been registered or is being used in ***bad faith***.
